

PLOGGING FOR THE OCEAN CONTEST

OFFICIAL CONTEST RULES ("RULES")

1. CONTEST PERIOD

The Ocean Wise Plogging for the Ocean Contest is administered by the Ocean Wise Conservation Association (the "**Sponsor**"). The Contest will be open for submissions beginning at 12:01 am PT on June 1st, 2026 and closing at 11:59 pm PT on July 31, 2026. (the "**Contest Period**").

2. ELIGIBILITY

The Contest is open to residents of Canada, excluding Quebec over the age of eighteen (18). Employees, agents, and representatives of the Sponsor, its affiliates, promotional agencies, and suppliers, as well as their immediate family members (brothers, sisters, children, parents) or spouses, or persons with whom they are domiciled, **are eligible to participate**, provided that individuals directly involved in the development, administration, or adjudication of the Contest are not eligible. The Sponsor reserves the right to verify eligibility and ensure the integrity of the Contest.

3. HOW TO ENTER

Any person who wishes to participate in the Contest and who satisfies the eligibility conditions set out above (each, a "**Participant**") may register on the Ocean Wise Shoreline Cleanup portal at <https://app.ocean.org/app/cleanup>. Each data card submitted is one "**Entry**", up to a maximum of **five entries per person**.

Submission of an entry to the Contest signifies that you have read and agree to the Contest Rules. By submitting an entry to the Contest through the Website or any other electronic platform, you agree that the act of submitting the entry to the Contest is a binding form of your electronic signature, which you agree binds you to these Contest Rules.

4. PRIZES

There is one (1) Garmin Forerunner 570 prize available to be won (ARV \$629.99 CAD), one (1) of three (3) Native Shoes digital gift cards (ARV \$200CAD each) and one (1) Ocean Wise/Ocean Week Canada swag pack (ARV \$100CAD) (the "**Prizes**").

5. ODDS

Odds depend on the number of eligible Entries received.

6. AWARDING PRIZES

- (a) A **random** draw will be held to determine the winner of the Garmin Forerunner 570 at approximately 2:00 pm PT on August 8th, 2026 at the Ocean Wise head office. Each data card submitted is one Entry, up to a maximum of **five entries per person**. The selected Participant will be contacted by phone or email. The Sponsor will administer a time-limited math skill-testing question to the selected Participant.
- (b) Data cards will be analyzed at approximately 2:00 pm PT on August 8th, 2026 to determine the cleanup events during the Contest Period that covered the longest cumulative distance. The organizers of the top three (3) cleanups will each receive a digital gift card of \$200 for Native Shoes to distribute amongst their cleanup participants.

- (c) Instagram and Facebook social media will be assessed at approximately 2:00 pm PT on August 8th, 2026 to determine the Participant with the best social media as determined by Ocean Wise's social media specialist.
- (d) If the selected Participant (i) does not comply with these Contest Rules; (ii) has not provided the correct answer to the skill-testing question; (iii) does not claim the Prize; or (iv) refuses the Prize, then the selected Participant may not be declared a winner, and Ocean Wise may at its discretion select another Participant by random draw, and repeat the Prize awarding steps under this section 6.

7. ACCEPTANCE OF THE PRIZE

The Prize must be accepted as awarded and is not be subject to transfer, exchange or substitution for an award of cash or otherwise, except that the Sponsor reserves the right to substitute the Prize, in whole or in part, for another prize of equivalent or greater value if the Prize is not available for any reason whatsoever.

By entering this Contest, individuals consent to the collection, use and disclosure of their personal information for the purposes of promotion and publicity purposes, in any format or medium, without compensation or prior notice.

All decisions of the Sponsor, or any Contest judging organization or Contest judge as designated by the Sponsor, are final and binding in all matters relating to this Contest and on all entrants without right of appeal, including, without limitation, any decisions regarding the eligibility/disqualification of Entries. The Sponsor and other Released Parties will not be responsible for illegible, incomplete, lost, misdirected, errors, failures or late Entries which will be void.

The Sponsor reserves the right at its sole and absolute discretion to disqualify, from this Contest and any future contest or other promotion conducted by the Sponsor, any person that they find or believe to be not in compliance with these Rules, to be tampering with the entry process or the operation of the Contest; or to be acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. ANY ATTEMPT BY AN ENTRANT OR ANY OTHER PERSON TO DELIBERATELY DAMAGE ANY COMPUTER OR COMMUNICATIONS SYSTEM (INCLUDING BUT NOT LIMITED TO THE SPONSOR'S WEBSITE AND MERCHANT SYSTEMS) OR UNDERMINE THE LEGITIMATE OPERATION OF THE CONTEST IS A VIOLATION OF CRIMINAL AND CIVIL LAWS AND, SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW.

Any use of automated devices to enter this Contest is prohibited. No correspondence will be entered into except with selected entrants. The Contest is subject to all applicable federal, provincial, and municipal laws.

IN NO EVENT SHALL THE SPONSOR BE REQUIRED TO AWARD MORE PRIZES THAN INDICATED IN THESE RULES OR TO AWARD A PRIZE OTHERWISE THAN IN COMPLIANCE WITH THESE RULES, FOR ANY REASON. In the event that more prizes are awarded than indicated due to any error, the Sponsor, in its sole and absolute discretion, may choose to hold a draw to determine which entrants are awarded such prizes.

11. RIGHT TO TERMINATE OR AMEND

The Sponsor reserves the right, to terminate, suspend or amend this Contest and or amend these Rules, in whole or in part, at any time and without prior notice if any factor interferes with its proper conduct as contemplated by these Rules. In the event of Contest termination, any remaining prize still to be won will, in the Sponsor's sole discretion, be deemed expired and void and will be ineligible for Contest play, and, without limiting any other provision of these Rules, the Released Parties will not have any further liability with respect thereto.
